SWCC Co-Op for Virtual Learning in CCPS Program Detail:

SWCC is offering a supervision program for kids in Kindergarten through 5th grade during the Virtual Learning decision for Coweta County Public Schools.

SWCC Co-Op for Virtual Learning will provide a place where students enrolled in face to face school option for 2020-2021 have a safe place to complete their coursework and virtual classes in a small group setting. They will also be afforded the opportunity to socialize with fellow students in a group with two adults and 12 kids.

Option 1: Hours: 7:15 a.m.-4:00 p.m., Monday through Friday \$125

Option 2: Hours: 7:45-2:45, Monday through Friday \$105

Option 3: Hours: 7:45-2:45 -Tuesday/Thursday \$45

Kids will be

- given assistance in logging onto their assigned class times.
- Provided with guidance and reminders to complete assigned tasks.

We would provide a <u>statement of acknowledgement</u> for parents to sign our protocols for safety, security, and health as well as the policy if a child in a specific group is diagnosed with Covid-19. It will be clearly stated that we are not a teacher or tutor, but a support system to provide supervision during the school day.

Facilitators would be screened by

Application, Reference checks, Criminal Background checks, and Ministry Safe Training as well as a signed acknowledgment of this as an Alcohol, Tobacco and Controlled-substance free zone.

Child Applications will be received and acceptance will be granted as space comes available:

- We will try to group by grade-level according to numbers.
- Grade Options Kindergarten through 5th grade

Requirements for enrollment:

- Proof of enrollment in Coweta County Schools
- Only for those originally enrolled in the traditional face-to-face model, not the Empower Program
- Chromebook (fully charged), charger
- Headphones with mic-capability
- Log-in information for Google Classroom, other platforms utilized by child and communication from teacher regarding schedule.
- Daily Lunch
- Snack
- Refillable Water Bottle
- Required items and assignments from school teachers
- No outside items other than listed above

What we provide:

- Assistance in logging onto their assigned class times.
- Guidance and reminders to complete assigned tasks.
- Classrooms with limited size (max is 12)
- Individual pencil boxes that will be assigned to students with scissors, pencils, eraser and crayons, if needed

- Outdoor Time
- Internet for school activities. (reliant on devices provided by student)

What we are not:

- A school environment
- Supplementing coursework provided by the Coweta County School system.

Fee Schedule:

Option 1: 7:00-4:00-Weekly Fee \$120,

Option 2: 7:45-2:45 Fee \$110, Option 3: 7:45-2:45, Fee \$45

Late Pick-up will be at 4:05 for kids in Option 1 and 2:55 for kids in Option 2 or 3. For any child that is not picked-up by an approved person by the time specified above, a \$5 fee per 5 minutes will be charged.

Payment:

Payment will be expected in advance on the Friday prior to the week's attendance. If payment is not received, a \$10 late fee will be charged per child. Payment will be expected regardless of attendance.

Group Rules:

- Raise your hand if you'd like to speak.
- Don't speak if someone else is speaking.
- Don't leave the group without permission.
- Be kind and gentle to each other at all times.

We reserve the right to dismiss kids from the program who are noncompliant or inhibit other children's learning.

Frequently Asked Questions:

Cost?

We are striving to keep costs minimal. The current fees are as follows:

Option 1: Hours: 7:00 a.m.-4:00 p.m., Monday through Friday \$125

Option 2: Hours: 7:45-2:45, Monday through Friday \$105

Option 3: Hours: 7:45-2:45 -Tuesday/Thursday \$45

Social Distancing, temperatures, masks, and cleaning procedures?

- We are going to distance kids as feasible. Kids will be seated at opposite ends of tables, limited to interaction with their group of 12 kids, and encouraged hand washing and hand sanitization.
- Masks will be worn in hallways and when the chance of interacting with other groups of kids is likely.
- Temperatures will be taken upon arrival each day of all staff and children. Anyone with a temperature of 99.5 or higher will be noted and parents informed. If a temperature of 100.2 or higher is noted then admittance will not be granted.
- Teachers will wear masks when in close proximity to children and when interacting with adults.
- Everyday classrooms will be sanitized and cleaned using CDC Approved procedures and chemicals.

Will my child be given support in their learning?

Kids will be given assistance in logging onto their assigned class times.

Provided with guidance and reminders to complete assigned tasks.

However, we will not be providing instruction on subjects for your child.

How will kids be grouped?

We will group kids according to grade level. Some grades may be combined in order to provide adequate staffing and group numbers. Minimum group size is 10, maximum is 12.

How long will this program last?

This program will be offered five days a week during the virtual learning season, currently through September 4, 2020.

At the time of the periodic assessments conducted by the CCPS Board and a decision is not made to go back to full time face-to-face learning a questionnaire will be sent to each family participating in the SWCC Co-Op program to opt in or out for continued enrollment. If a hybrid option is given, we will have to reassess the program structure and viability.

I don't need 5 days a week, are their other options?

Possibly, given the popularity of a 2 day option, we are opening that up for enrollment but it is contingent on enrollment and facilitators available.

My kid has an IEP or 504 plan, can they be accepted?

Kids with IEP or 504 Plans can apply, but will only be accepted as we are capable of serving the best needs of the child.

Are their discounts or scholarships available?

There may be availability for discounts or scholarships soon, but it would be based on if a sponsor could be identified.
